Dear Fellow Orangewood Homeowners,

It is the end of the year already- and we have been busy as usual!

- First of all, we updated our Bylaws. This was a major undertaking involving many meetings and lots of community input. The new Bylaws can be viewed on our website. We are now reviewing Orangewood Standards for Home Maintenance. These will be posted when they are approved at a future meeting.
- Lots of changes to the playground! Go see the new blue rubber mulch we installed this year – it will last for many years. We replaced the broken double slide and mirror, and we also purchased a new playground equipment storage box and 2 new tennis court rollers. Sometime soon there will also be a new spin ride!
- Cleaned up dead trees/branches at the Lander entrance and along all of the trails
- Enhanced the beds at each entrance with additional plantings.
- Added gravel to resurface the path from Laurel Circle to East Ash/White Oak.

1. LEAF COLLECTION IS OVER FOR THIS YEAR. Please have your landscaper remove any piles of leaves or branches from near the road. Remember, tree branches, leaves and grass clippings are not to be dumped on any common property or streambed by you or your LANDSCAPER.
2. Please put out garbage receptacles on Sunday night and not before. They must be placed by 7 am on Monday morning.
3. Please pick up after your pets.
4. The board encourages all homeowners to use and enjoy our common property and trails for recreational purposes. Homeowners are reminded that no one is permitted to use Orangewood common property and amenities for the purpose of making money (charging for an activity or lesson).
